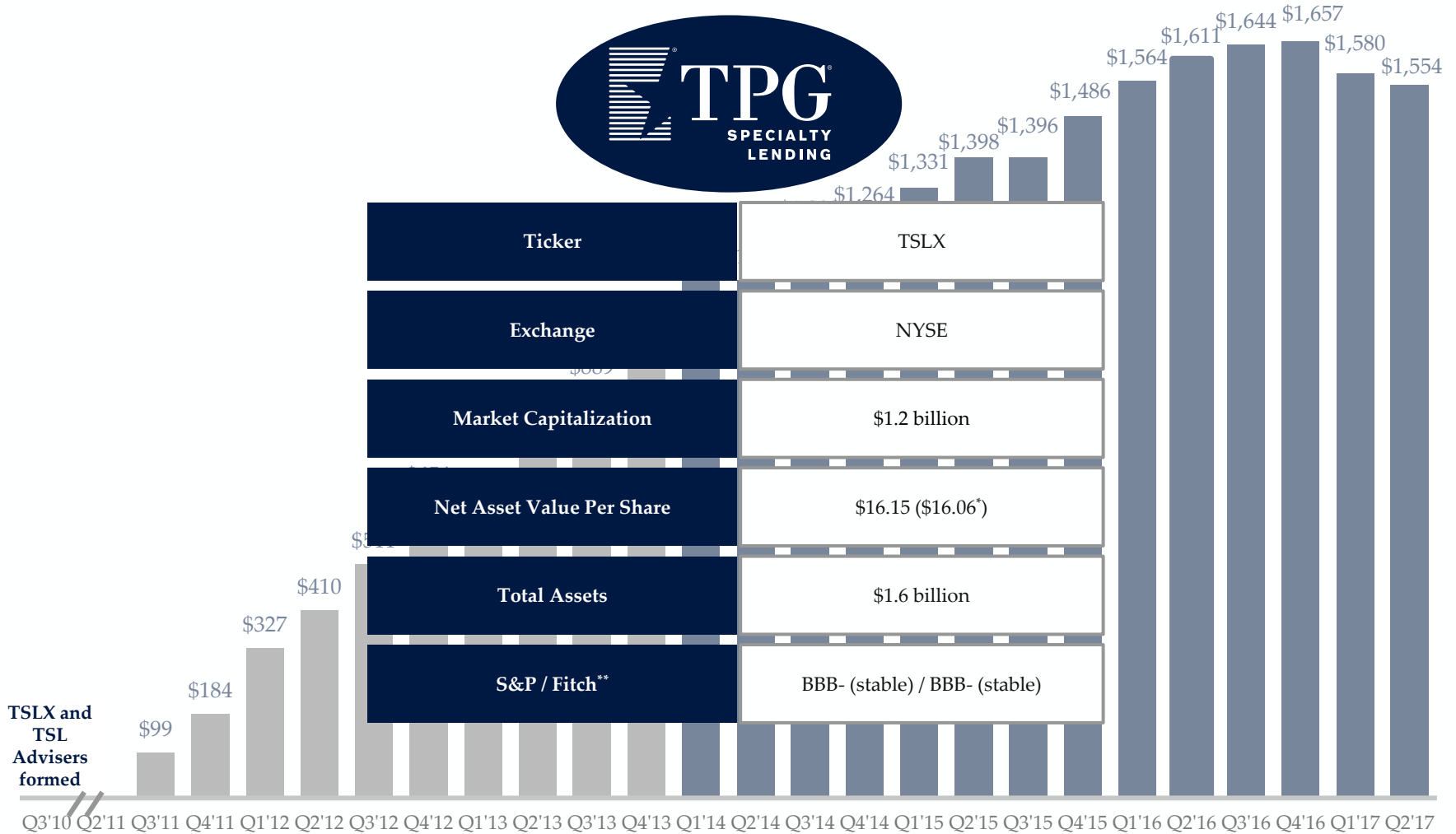

## Broadly distributed, scaled senior floating rate-focused portfolio

- ▶ Core focus on investing in middle-market loans to U.S. based companies
  - Target EBITDA: \$10 million to \$250 million
  - Portfolio weighted average EBITDA: \$23 million<sup>(1)</sup>
- ▶ Target average investment hold size of \$30 million to \$100 million
- ▶ Diversified portfolio of investments in 46 portfolio companies with an average investment size of \$34 million; largest investment represents 4.9%
- ▶ Portfolio of 97% secured, 93% first-lien debt investments; 100% floating rate\*

## Leading platform with proprietary, directly originated deal flow

- ▶ External advisor part of TPG Sixth Street Partners, with over \$19 billion of credit related assets under management

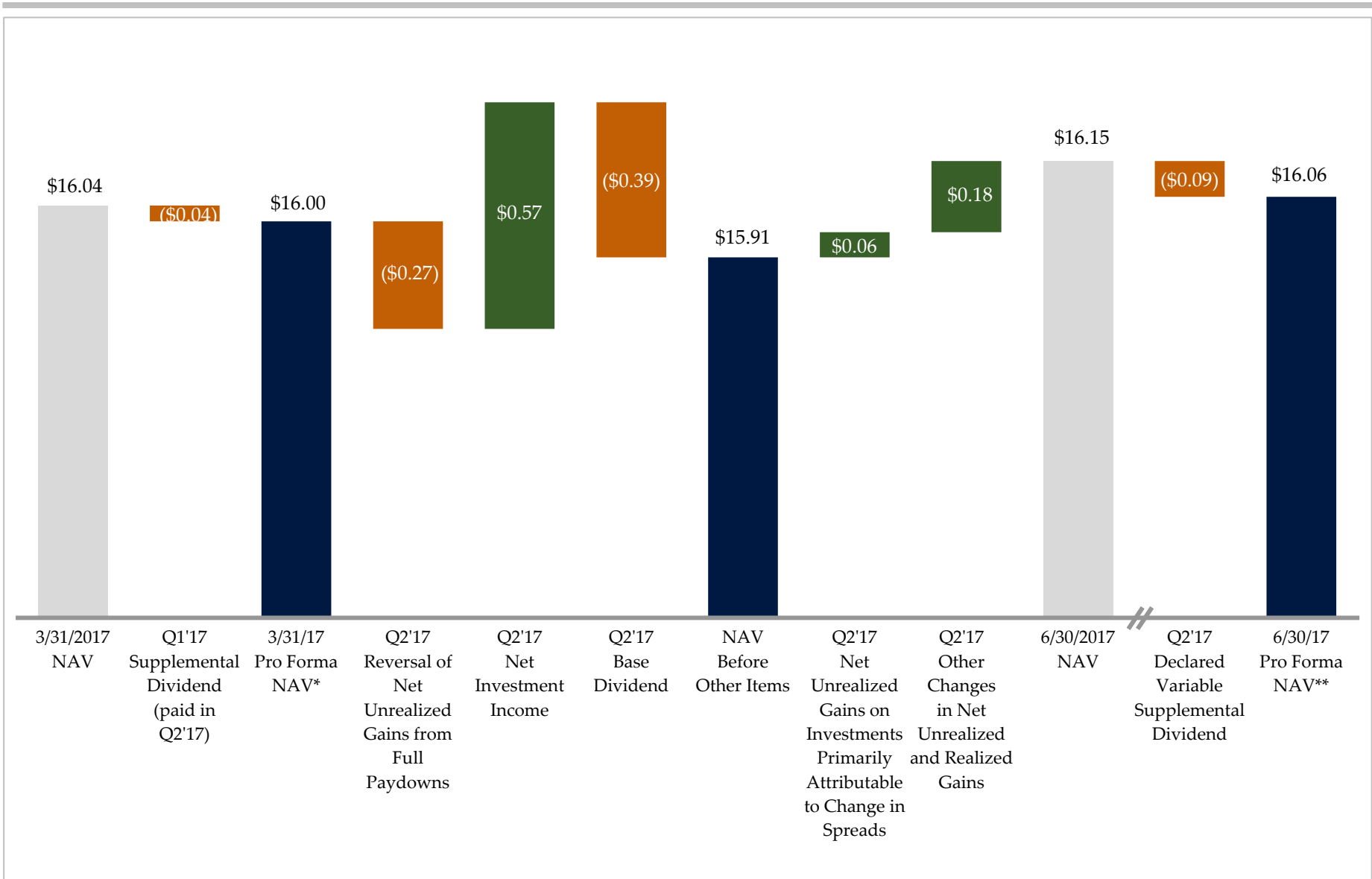

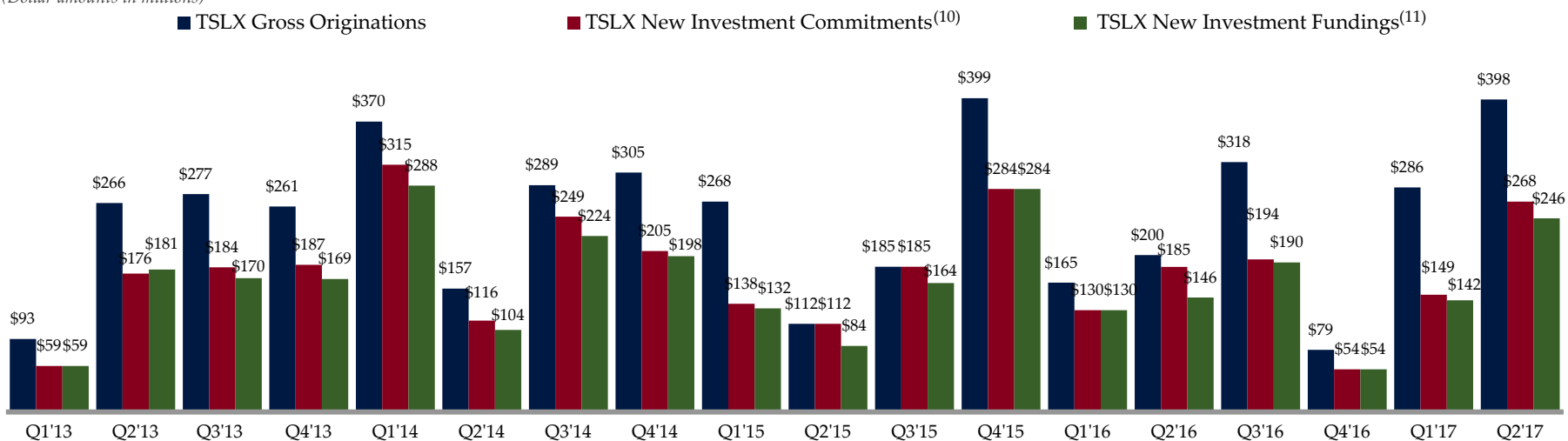

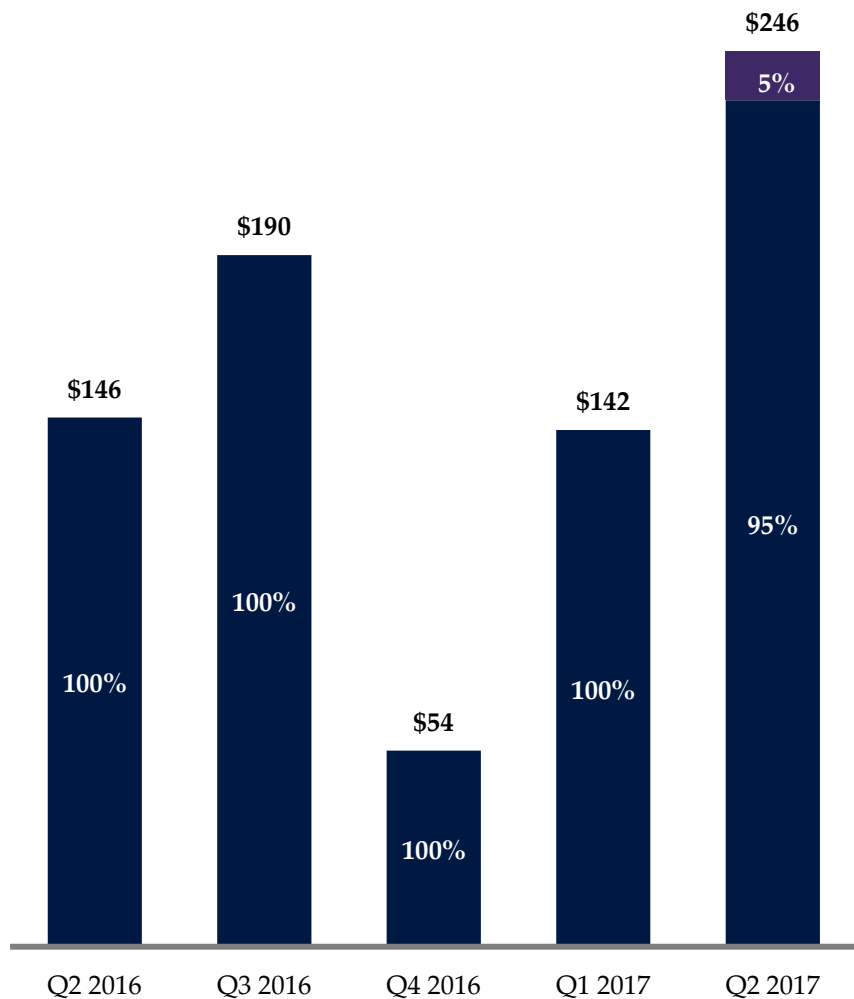

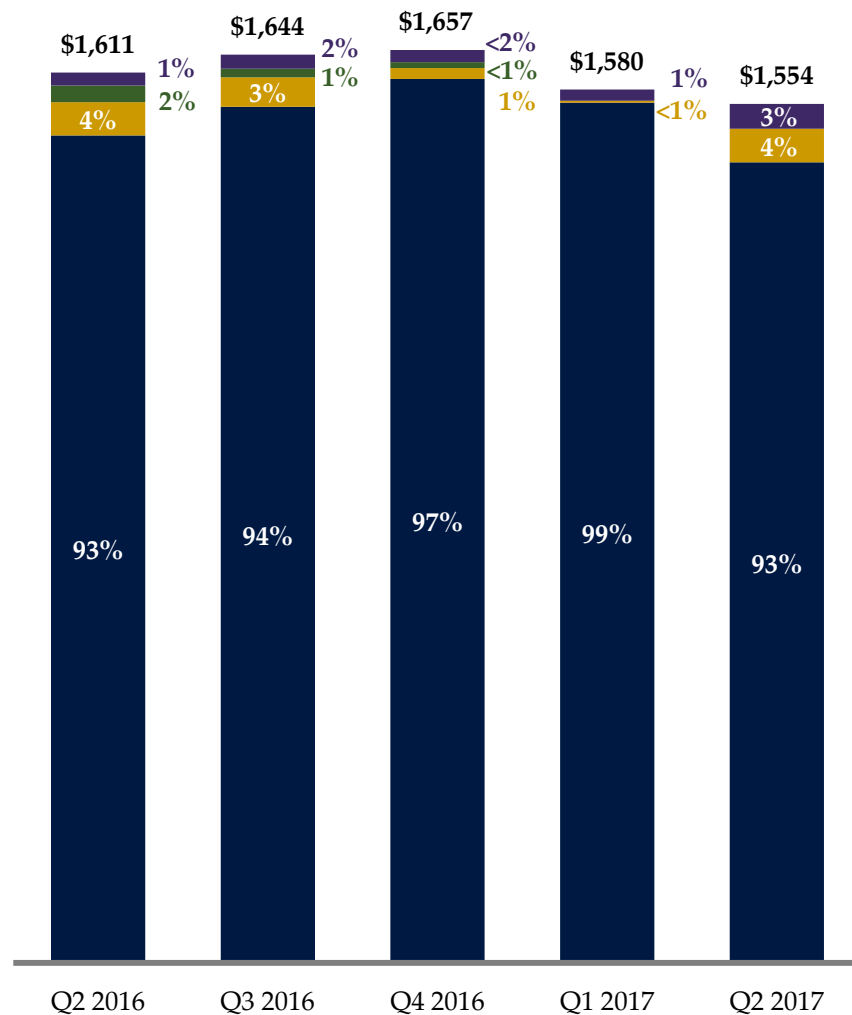

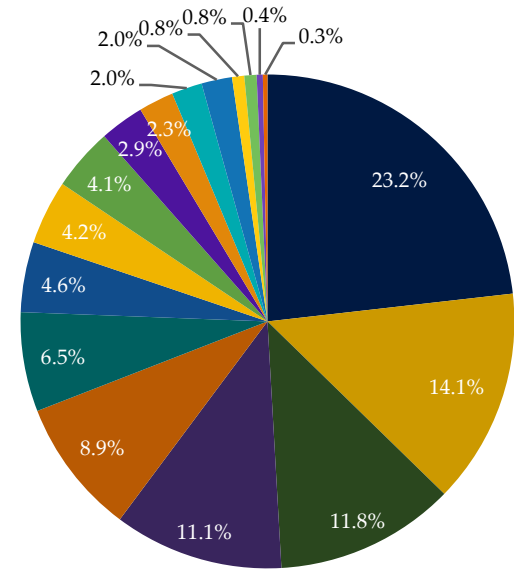
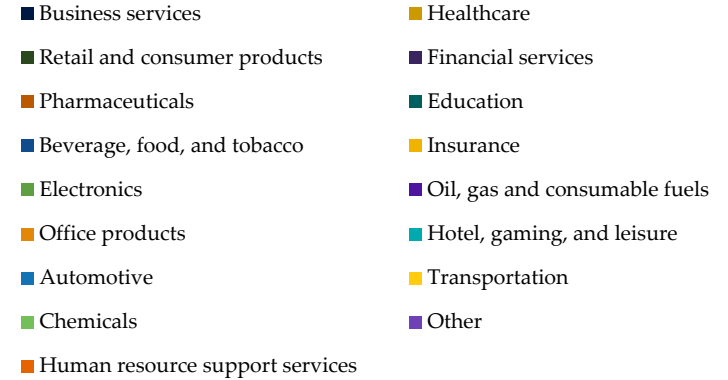


# Portfolio Highlights – Diversification Across Borrowers and Industries

## TOP 10 BORROWER DIVERSIFICATION



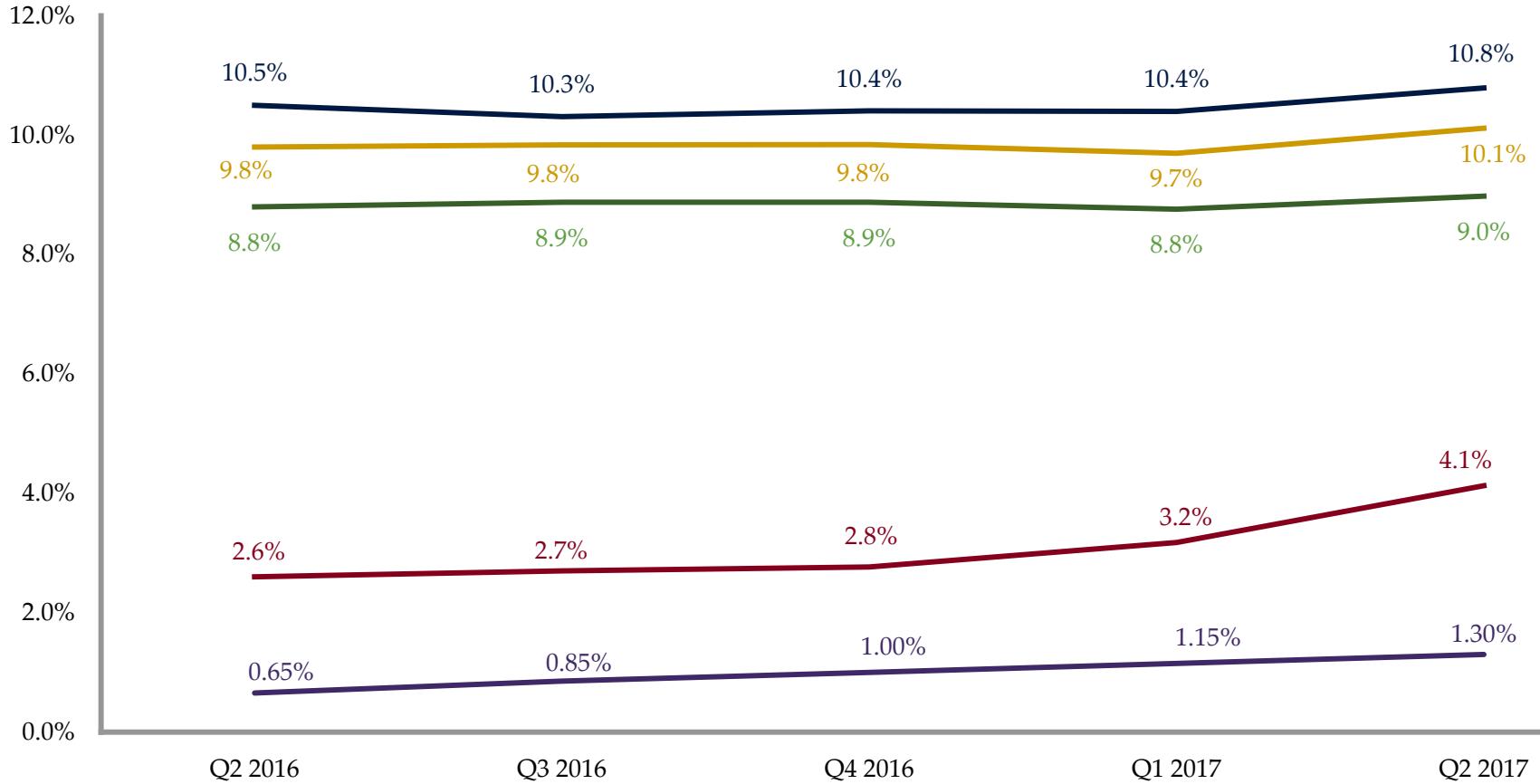
## INDUSTRY DIVERSIFICATION

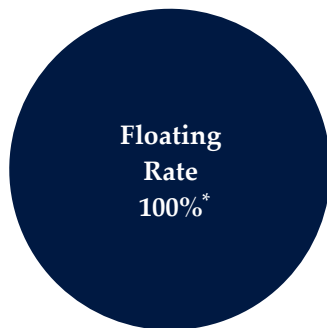

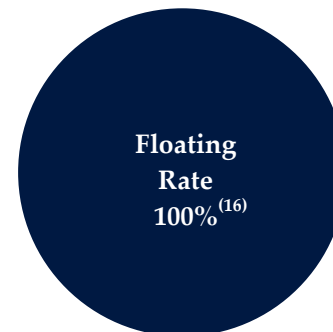

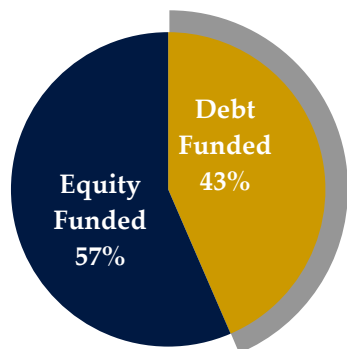
### DEBT PORTFOLIO COMPOSITION



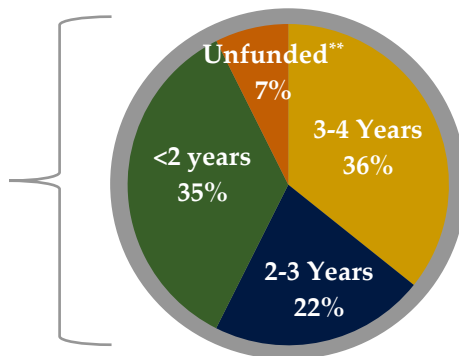
### FLOATING RATE DEBT



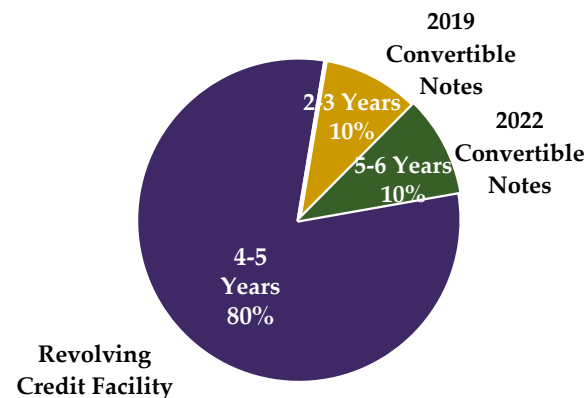
### PORTFOLIO FUNDING PROFILE<sup>(3)</sup>

- 2) Return on Average Equity is calculated using weighted average equity. Weighted average equity is calculated by starting with NAV at the beginning of the period, adjusting daily for equity issuances and adjusting on the last day of the period for that period's net income and dividends payable
- 3) Deferred Financing Costs total \$9.2mm at 6/30/16, \$8.6mm at 9/30/16, \$11.0mm at 12/31/16, \$14.1mm at 3/31/17, and \$13.3mm at 6/30/17
- 4) Pro-forma for unsettled trades of \$0 at 6/30/16, -\$3mm at 9/30/16, \$0 at 12/31/16, -\$7mm at 3/31/17 and \$0 at 6/30/17
